CNMI PUBLIC SCHOOL SYSTEM (PSS) CONSTRUCTION OF MARIANAS HIGH SCHOOL CAREER AND TECHNICAL EDUCATION CENTER (MHS-CTEC)

COMMONWEALTH PORTS AUTHORITY (CPA) DELTA DOCK REHABILITATION AND EXTENSION PROJECT

The Division of Coastal Resources Management (DCRM) will be holding a public hearing for the following project:

<u>CRM Major Siting Application No. SMS-2025-022</u> The CNMI Public School System (PSS) is proposing to construct the Marianas High School Career and Technical Education Center (MHS-CTEC). The development is situated on Lot No. 039 H 01, Susupe, Saipan.

<u>CRM Major Siting Application No. SMS-87-X-036-A1</u> The CNMI Commonwealth Ports Authority (CPA) is proposing to rehabilitate and extend the existing condemned Delta Dock structure and construct an emergency boat launching ramp dedicated for CPA use. The development is situated on Lot No. 011 E 13, Tanapag Harbor, Saipan.

The public hearing for this project is scheduled for Tuesday, July 15, 2025 at 5:00PM, at the DCRM Learning Center 3rd Floor, Suite 301, Gualo Rai Center, Middle Road, Lower Gualo Rai, Saipan.
