  - Achugao Watershed Management Plan (AWMP) Final Draft
    - Boundaries shifted slightly
      - ➤ Lower Base stream basin included in West Takpochao watershed
    - 10-year goals
      - 1. Reduce urban pollutant loads to Tanapag Lagoon by managing 30+ acres of existing impervious cover, applying better land use controls on new development, and maintaining infrastructure.
      - 2. Adopt predicted rainfall, sea level rise, groundwater elevations, and storm surge levels for a minimum 30-yr planning horizon (year 2050).
      - 3. Protect or restore 30% of the terrestrial and wetland habitats in the watershed through invasive species management, native reforestation, and land conservation.
      - 4. Empower community-based watershed stewardship by conducting at least 30 engagement, advocacy, and educational outreach activities.
        - ➤ AWMP includes potential project concepts/designs (see Appendix D)
      - 5. Adapting and expanding program in 2023 (final year under DOI grant)
        - > more focus on climate change suggested
    - Next steps
      - Draft review (WWG and other interested parties)
        - ➤ Submit feedback by Jan. 1, 2023

- All master plans... prepared for public agencies shall be submitted to the [OPD] Director for processing as part of the comprehensive planning program.
- Once adopted, signed by relevant parties to finalize plan.
- Aiming to have complete by (along with Saipan Wildfire Plan) by Q1 2023
