 - Watershed Warriors
 - > Year 2
 - 50% improvement in understanding overall, with 84% improvement in recognition of Achugao watershed
 - Adapting and expanding program in 2023 (final year under DOI grant)
 - more focus on climate change suggested
 - San Vicente rain garden restoration
 - ➢ completed July 1, 2022
 - included native wetland plant species
 - signage to be installed soon
 - Additional raingardens
 - Selected sites:
 - Tanapag Middle School (Achugao)
 - \circ continued support from school faculty
 - AMP / Boating Safety (Garapan)
 - support from NPS
 - Mangrove nursery
 - Permitting ongoing
 - on-track for installation/propagation in FY23
 - > Opportunity to replace existing invasive *Pluchea indica* with *Lumnitzera littorea*

 - Load modeling and restoration potential [complete]
 - Implementation strategy for review [current focus]
 - Goals & objectives
 - 1. Reduce watershed pollutant loads to Tanapag Lagoon by 30% through green infrastructure and better land use management.
 - 2. Restore 30 acres of native upland and wetland habitats through revegetation and invasive species management.
 - 3. Empower watershed communities and promote stewardship through 30 engagements, advocacy, and educational activities.
