*Atkins Kroll Saipan, Inc. is proposing to construct its new headquarters building and a Toyota-Lexus Dealership facility in Puerto Rico, Saipan. The project is situated on Lot No. E.A. 896-R2, measuring a total area of about 15,000 square meters, more or less, which borders with Route 30, Chalan Pale Arnold to the northwest, the U.S. Army Reserve complex, a vacant parcel to the northeast, the ANAKS Ocean View Condominiums to the east, and the Marianas Heights commercial buildings on the south side of the property.
