# NOTICE OF CRM PUBLIC HEARING

## HAWAIIAN ROCK PRODUCTS HAWAIIAN ROCK TINIAN QUARRY EXPANSION

The Division of Coastal Resources Management (DCRM) will be holding a public hearing for the following project:

CRM Major Siting Application No. TMS-2024-045 – Hawaiian Rock Products is proposing to expand its rock quarry operations to the adjacent leased public properties identified as Lot Nos. 266 T 11, measuring about 16,949 sq. m. and 266 T 12, measuring about 15,856 sq. m., or a combined total of about 32,805 sq. m. of public lands. The site will be used to quarry limestone materials by utilizing surface mining methods where a mechanical rock plane apparatus slices the rock into workable slabs.

The public hearing for this project is scheduled on **Tuesday, July 2, 2024, at 5:00PM**, at the **Tinian Elementary School Cafeteria, San Jose, Tinian**.
