Public Hearings are required for all new major siting projects. All public hearing notices are published in a local newspaper of general circulation. Residents of Rota and Tinian may submit comments and hearing requests to their local DCRM Coordinator. Persons wishing to retain the right to appeal a DCRM Permit decision must file a notice of appeal with the DCRM office within thirty (30) days of the issuance of the DCRM permit decision as provided in Part 200 § 15-10-235 of the DCRM Regulations.
