Dear Mr. Salas,

Thank you for the March 9, 2023, request for approval of changes to the Commonwealth of the Northern Mariana Islands (CNMI) Coastal Management Program pursuant to the National Oceanic and Atmospheric Administration (NOAA) Coastal Zone Management Act (CZMA) regulations at 15 CFR part 923, subpart H.¹

NOAA's Office for Coastal Management approves the request subject to the qualification below.

NOAA's regulations require that the state post this decision by the Office for Coastal Management for public notice.² The public notice should state that as of the date of this decision letter the enforceable policies identified in the attached Table of Approved Changes shall be applicable in reviewing federal actions pursuant to the federal consistency requirements of the CZMA and its implementing regulations found at 15 CFR part 930.³ Please send a copy of the public notice to the Office for Coastal Management for our records to close out this file.

PUBLIC AND FEDERAL AGENCY COMMENTS

The Office for Coastal Management did not receive any comments on this program change submission.

CLARIFICATION AND OUALIFICATION

At § 15-20-005, which describes the authority to issue the regulations for water sports (jet skis), it is stated that the regulations are issued pursuant to the federal Coastal Zone Management Act (16 c. § 1451 et seq.) and the Statement of Mutual Agreement and Memorandum of Understanding entered into by and between the Commonwealth and the

NOAA "which delegated" to the Division of Coastal Resources Management all authority respecting water sports and recreational activities. As a point of clarification, please note that state coastal management programs are not delegated authorities. While states are required to have management authority over land and water uses in order to obtain program approval and be eligible for CZMA grants and the authority to review federal actions for consistency with state enforceable policies, the NOAA Coastal Zone Management Program regulations do not specify how coastal land and water uses are to be managed. NOAA has no authority to manage the coastal land and waters uses within a state, nor direct how uses should be managed.

Throughout the regulations submitted for approval as enforceable policies for CZMA review purposes, there are sections with a mix of procedural and substantive requirements. Enforceable policies, approved for the purposes of CZMA review, are substantive standards used to determine the consistency of federal actions. Procedural requirements are not substantive standards and are not to be used to determine the consistency of federal actions. The Federal Consistency regulations recognize that requirements to obtain state permits may be used to determine consistency for federal licenses and permits but federal agencies are not required to obtain state permits (nor pay fees) unless required to do so by federal law.

As a standard qualification applying to all program changes, states may not incorporate enforceable policies by reference. If an approved enforceable policy refers to another statute, regulation, policy, standard, guidance, or other such requirement or document, the referenced policy must be submitted to and approved by the Office for Coastal Management as an enforceable policy in order to be applied under the federal consistency review provisions of the CZMA. No referenced policy may be applied for CZMA federal consistency review purposes unless that policy has been separately reviewed and approved as an enforceable policy by the Office for Coastal Management.
