USA FANTER CORPORATION LIMITED USA FANTER KANNAT TABLA QUARRY & BATCHING PLANT FACILITY

The Division of Coastal Resources Management (DCRM) will be holding a public hearing for the following project:

CRM Major Siting Application No. CRM-MS2022-0003 (formerly SMS-2012-X-061-A1) – The USA Fanter Corporation Limited is proposing to construct a cement batching plant, hollow block manufacturing facility, and to extend the use and operation of its quarry operation on public lands identified as Lot Nos. 040 H 12 and 040 H 13 in Kannat Tabla, Saipan. USA Fanter Corporation, Ltd., has leased the two properties from the Department of Public Lands (DPL) under a Temporary Lease Agreement, No. 22-001S for five (5) years.
