

The Public is invited to submit written comments regarding any of the above projects for which a permit decision has not been issued. All permit comments should identify the project by application number. Your comments should be mailed or hand-delivered to the DCRM Office. All persons who desire a public hearing regarding any project may do so by submitting a written request for a public hearing to the DCRM Office within fourteen (14) days for minor permits (APCs) and proposed amended major siting's. Public Hearings are required for all new major siting projects. All public hearing notices are published in a local newspaper of general circulation. Residents of Rota and Tinjan may submit comments and hearing requests to their local DCRM Coordinator. Persons wishing to retain the right to appeal a DCRM Permit decision must file a notice of appeal with the DCRM
